To The Honorable Roy Cooper, Governor of North Carolina:

I hereby respectfully submit the 2017 Annual Report of the Commissioner of Banks. The report provides financial information for the calendar year ended December 31, 2017, regarding North Carolina state-chartered commercial banks, savings banks, and nondepository trust companies under supervision of the Office of the Commissioner of Banks.

Although economic challenges continued in 2017, North Carolina state-chartered banks showed continued signs of improvement and experienced a generally favorable year. Overall asset levels decreased 7.6 percent during the year, primarily due to the acquisition of six North Carolina state-chartered banks by institutions headquartered outside of this state. However, 76 percent of North Carolina's state-chartered banks experienced asset growth during the year, with five institutions attaining a growth rate of 40 percent or more: HomeTrust Bank, Asheville; Live Oak Banking Company, Wilmington; Select Bank & Trust Company, Dunn; First Carolina Bank, Rocky Mount; and First Capital Bank, Laurinburg.

In the aggregate, North Carolina's state-chartered banks and savings institutions also improved their asset quality. The delinquency ratio, which is a measurement of past-due and nonaccrual loans and leases to total loans and leases, declined from 1.89 percent to 1.61 percent. In addition, Other Real Estate Owned, an asset category comprised of foreclosed real estate collateral, decreased by 50 percent from year-end 2016.

Most of North Carolina's state-chartered institutions were also successful in maintaining generally favorable levels of profitability, although some key ratios declined slightly. In 2017, the aggregate return on average assets for state-chartered banks and savings institutions increased three basis points from 0.66 percent to 0.69 percent, while the net interest margin dropped from 3.71 percent to 3.68 percent. The decrease in the net interest margin is largely due to the continued low interest rate environment.

Most institutions are well-capitalized and are viable and important contributors to the communities and markets they serve. The Office of the Commissioner of Banks remains committed to and is focused on ensuring that all institutions under its supervision operate in a safe and sound manner, with adequate capital and capable management.

## 2017 Legislative Summary

The following is a brief summary of significant changes made during the 2017 session of the North Carolina General Assembly to the laws over which the Office of the Commissioner of Banks has regulatory jurisdiction or which directly affect the activities of the Office or of those entities which it licenses or otherwise regulates. Refer to the Session Laws indicated for details.

#### I. S.L. 2017-165 (H. 462) Banking Law Amendments.

This Act makes technical and clarifying changes to provisions applicable to commercial banks and bank holding companies. This Act also repeals Article 18 of Chapter 53, the North Carolina Bank Holding Company Act of 1984, and transfers specific provisions to Article 10 of Chapter 53C.

Effective: July 21, 2017.

#### II. S.L. 2017-25 (H. 144) Credit Union/Trust Institution Changes.

This Act includes trust institutions among the financial institutions that are permitted to hold funds in escrow or on deposit in various statutes.

Effective: June 2, 2017.

#### III. S.L. 2017-23 (H. 228) Postpone Assumed Name Revisions.

This Act postpones the implementation of the Assumed Business Name Act, as recommended by the General Statutes Commission, because the database will not be operational by the current implementation deadline. This may impact licensing requirements for certain non-depository applicants.

Effective: June 2, 2017.

#### IV. S.L. 2017-102 (H. 229) GSC Technical Corrections 2017.

This Act makes technical revisions to the General Statutes as recommended by the General Statutes Commission. The Act makes numerous stylistic changes to the Money Transmitters Act in Article 16B of Chapter 53.

Effective: July 12, 2017
