To The Honorable Roy Cooper, Governor of North Carolina:

I hereby respectfully submit the 2018 Annual Report of the Commissioner of Banks. The report provides financial information for the calendar year ended December 31, 2018, regarding North Carolina state-chartered commercial banks, savings banks, and nondepository trust companies under supervision of the Office of the Commissioner of Banks.

During 2018, North Carolina state-chartered banks showed continued signs of improvement and experienced a generally favorable year. Overall asset levels increased 1.5 percent during the year, compared to a net decrease of 7.6 percent in 2017. Several institutions in the state realized healthy growth rates during the year and the following five banks each attained 35 percent or more growth in total assets: First Carolina Bank, Rocky Mount; Roanoke Rapids Savings Bank, SSB, Roanoke Rapids; Providence Bank, Rocky Mount; Live Oak Banking Company, Wilmington; and Sound Bank, Morehead City.

In the aggregate, North Carolina's state-chartered banks and savings institutions also improved their asset quality. The delinquency ratio, which is a measurement of past-due and nonaccrual loans and leases to total loans and leases, declined from 1.61 percent to 1.58 percent. In addition, Other Real Estate Owned, an asset category comprised of foreclosed real estate collateral, decreased by 16 percent from year-end 2017.

The majority of North Carolina's state-chartered institutions maintained favorable levels of profitability, with most key ratios showing year-over-year improvement. In 2018, the aggregate return on average assets for state-chartered banks and savings institutions increased 22 basis points from 0.67 percent to 0.89 percent, while the net interest margin increased from 3.68 percent to 3.90 percent. The increase in the net interest margin is largely due to a notable increase in yields on average earning assets.

Most institutions are well-capitalized and are important contributors to the communities and markets they serve. The Office of the Commissioner of Banks remains committed to and is focused on ensuring that all institutions under its supervision operate in a safe and sound manner, with adequate capital and capable management.

2018 Legislative Summary

The following is a summary of some significant changes made during the 2018 session of the North Carolina General Assembly, which adjourned on June 29, 2018, to the laws over which the Office of the Commissioner of Banks (the "OCOB") has regulatory jurisdiction or which directly affect the activities of the OCOB or of those entities which it licenses or otherwise regulates. Refer to the Session Laws indicated for details.

S.L. 2018-23 (H.B. 86) Makes changes to the Money Transmitters Act.

In 2016, the General Assembly passed the Money Transmitters Act (S.L. 2016-81) which modernized existing laws to reflect current business practices of both traditional and virtual currency money transmitters. This Act clarifies changes to permissible investments and statutory trusts under the Money Transmitters Act:

- **Section 1:** This Act removes the brick and mortar requirement from the definition of an "authorized delegate." It also amends the definition of "permissible investments" by:
 - 1) reducing the value of receivables due to the licensee from no more than 90-days past due to no more than 30-days past due; and
 - 2) no longer requiring the licensee to own virtual currency.

Section 2: This section of the act allows the OCOB to require a licensee who possesses virtual currency as a permissible investment to provide proof to the OCOB of all their virtual currency, and including that stored offline.

The Effective date was: June 22, 2018.
