To The Honorable Roy Cooper, Governor of North Carolina:

I hereby respectfully submit the 2019 Annual Report of the Commissioner of Banks. The report provides financial information for the calendar year ended December 31, 2019, regarding North Carolina state-chartered commercial banks, savings banks and nondepository trust companies under supervision of the Office of the Commissioner of Banks.

During 2019, North Carolina state-chartered banks showed continued signs of improvement and experienced a generally favorable year. Aggregate total assets of North Carolina state-chartered banks increased significantly during the year, primarily due to the merger of SunTrust Bank, Atlanta, Georgia, and Branch Banking and Trust Company ("BB&T"), Winston-Salem. The combination of these two institutions to form Truist Bank, headquartered in Charlotte, increased aggregate total assets in North Carolina by approximately \$242 billion. Apart from the impact of this merger, several other institutions in the state realized healthy growth rates during the year. The following five banks each attained 15 percent or more growth in total assets: First Capital Bank, Laurinburg; Live Oak Banking Company, Wilmington; First Carolina Bank, Rocky Mount; Dogwood State Bank, Raleigh; and blue harbor bank, Mooresville.

Also noteworthy for the year was the opening of American Bank of the Carolinas, headquartered in Monroe, the first *de novo* bank in North Carolina since 2009.


Overall asset quality of North Carolina's state-chartered banks and savings institutions improved during 2019. The aggregate delinquency ratio, a measurement of past-due and nonaccrual loans and leases to total loans and leases, declined from 1.58 percent to 1.35 percent. However, the aggregate level of Other Real Estate Owned, an asset comprised of foreclosed real estate, increased slightly during the year.

The majority of North Carolina's state-chartered institutions maintained favorable levels of profitability, although some key ratios declined during the year. In 2019, the ratio of net income to average total assets declined from 0.89 percent to 0.63 percent, while the net interest margin dropped from 3.90 percent to 3.80 percent. These declines are largely attributable to the challenges of operating in a low interest rate environment.

Most institutions are well-capitalized and are important contributors to the communities and markets they serve. The Office of the Commissioner of Banks remains committed to and is focused on ensuring that all institutions under its supervision operate in a safe and sound manner, with adequate capital and capable management.

2019 Legislative Summary

The following is a summary of some significant changes made during the 2019 session of the North Carolina General Assembly, which adjourned in November 2019, to the laws over which the Office of the Commissioner of Banks (the “OCOB”) has regulatory jurisdiction or which directly affect the activities of the Office or of those entities which it licenses or otherwise regulates. Refer to the Session Laws indicated for details.

Joint Resolution 147 (Resolution 2019-6) Confirm Ray Grace

This Act is a joint resolution to confirm the Governor’s reappointment of Ray Grace as Banking Commissioner for the North Carolina Office of the Commissioner of Banks for a 4-year term.

Effective: April 4, 2019.

S.L. 2019-173 (H.B. 628) Banking & Mortgage

This Act requires the governor to appoint a representative of the mortgage industry that is licensed under Article 19B of Chapter 53 of the General Statutes and seven public members to the State Banking Commission.

This Act also eliminates an outdated “abstract of financial conditions” publication requirements for savings banks and savings & loans. It gives banks parity with credit unions by allowing commercial banks, savings banks and savings & loans associations to offer savings promotions.

Effective March 21, 2021.

S.L. 2019-10 (S.B. 162) Loan Origination/Late Payment Charge Changes.

This Act modernizes the loan origination fee for North Carolina Banks and adjusts the late payment charge for certain loans under Chapter 24.

Effective: March 27, 2019.

S.L. 2019-113 (S.B. 394) Amends §§ 36C-2-203 & 36C-4-411

This Act makes various changes to the General Statutes concerning estates, trusts, and guardianships.

Section 4 of the bill clarifies that, notwithstanding § 1-56, actions to reform, terminate, or modify a trust, pursuant to § 36C-4-410 through § 36C-4-416, may be commenced at any time.

Section 5 of this Act clarifies that an action seeking to add trust terms to provide for removal and replacement of the trustee by one or more beneficiaries or other persons is an action to reform or modify a trust over which the clerk of superior court does not have jurisdiction.

Effective July 11, 2019

S.L. 2019-53 (H.B. 531) Protecting Tenants at Foreclosure Act Restored.

§ 45-21.29. Orders for possession.

This Act makes changes to the General Statutes to reflect the restoration of the federal Protecting Tenants at Foreclosure Act and deletes those provisions of State law that were enacted to provide protections when the federal act had sunset.

Effective: October 1, 2019.

S.L. 2019-77 (S.B. 229) Fees on Returned Checks/Loan Processing.

This Act amends § 25-3-506, collection of processing fees for returned checks by the payor's bank because of insufficient funds or because the drawer did not have an account at the bank by increasing the processing fees for a check in payment for goods or services from twenty-five dollars (\$25.00) to thirty-five dollars (\$35.00).

Effective: October 1, 2019.

S.L. 2019-91 (H.B. 770) Freedom to Work/OLB Reform

This Act clarifies and simplifies a licensee's qualification for licensure requires recognition by licensing boards of certain apprenticeship and training experiences.

The Act does the following:

- 1) Requires administrative agencies, governmental officials, and courts in civil proceedings to consider a certificate of relief favorably.
- 2) Defines a "State agency licensing board."
- 3) Clarifies standards for a licensing board of an applicant's criminal history in making determinations.
- 4) Requires recognition of licensing boards of certain apprenticeship and training experiences.

Effective: October 1, 2019.

S.L. 2019-140 (H.B. 590) Amendment to the Administrative Procedure Laws

This Act makes changes to the Administrative Procedure Act as recommended by the Office of Administrative Hearings and the Rules Review Commission:

This Act provides that technical changes would no longer need to go before the Review Commission.

This Act provides that a person aggrieved by an agency action is not required to petition the agency for rule making or to seek or obtain a declaratory ruling before commencing a contested case.

This Act eliminates the category of necessary without substantive public interest so that all rule would be classified as either necessary or unnecessary. Rules that are classified as necessary would be subject to readoption.

Effective: October 1, 2019.

S.L. 2019-80 (S.B. 127) Protect Governmental Accountability.

This Act clarifies state agencies' obligation to refrain from interference with state employees' duty to report violations of state or federal law, fraud, misappropriation of state resources, and other governmental improprieties; and makes other changes to foster governmental accountability to prevent violations of state or federal law, fraud, misappropriation of state resources, and other governmental improprieties.

Effective: July 4, 2019.
