To The Honorable Roy Cooper, Governor of North Carolina:

I hereby respectfully submit the 2020 Annual Report of the Commissioner of Banks. The report provides financial information for the calendar year ended December 31, 2020, regarding North Carolina state-chartered commercial banks, savings banks, and non-depository trust companies under supervision of the Office of the Commissioner of Banks.

North Carolina state-chartered banks have responded well to the COVID-19 pandemic ("pandemic") that began in 2020, and have effectively navigated the largely unprecedented challenges presented by the crisis. Our banks continued to provide the necessary financial services to their customers with only minimal disruption. As encouraged by state and federal regulatory agencies, most of these institutions provided temporary payment concessions to their loan customers who had been negatively impacted by the pandemic. Moreover, a majority of the state-chartered banks in North Carolina participated in the Small Business Administration's Paycheck Protection Program ("PPP") by extending loans to entities that were financially distressed because of the pandemic. As a whole, financial services in North Carolina remained effective and stable during this difficult time.

Notwithstanding the adverse impact of the pandemic on the banking industry, North Carolina state-chartered banks managed to show continued signs of improvement during 2020 and experienced a generally favorable year. Aggregate asset levels increased during the year, with the following five banks attaining 30 percent or more growth (exclusive of growth attributed to the PPP): American Bank of the Carolinas, Monroe; Dogwood State Bank, Raleigh; First Carolina Bank, Rocky Mount; First Capital Bank, Laurinburg; and Live Oak Banking Company, Wilmington. Along with the increase in total assets, overall asset quality of North Carolina's state-chartered banks improved in 2020. The aggregate delinquency ratio, a measurement of past-due and nonaccrual loans and leases to total loans and leases, declined from 1.35 percent to 0.95 percent, while the aggregate level of Other Real Estate Owned, an asset comprised of foreclosed real estate, also declined during the year.

The majority of North Carolina's state-chartered institutions remained profitable during the year; however, some key profitability metrics declined from 2019 levels. In 2020, the ratio of net income to average total assets declined from 0.63 percent to 0.53 percent, while the net interest margin dropped from 3.80 percent to 3.29 percent. The decrease in these ratios is partially attributed to the challenges of operating in a low interest rate environment.

Also noteworthy for the year was the opening of Triad Business Bank, headquartered in Greensboro, the second *de novo* bank in North Carolina to begin operations over the previous two years.

Most institutions are well-capitalized and are important contributors to the communities and markets they serve. The Office of the Commissioner of Banks remains committed to and is focused on ensuring that all institutions under its supervision operate in a safe and sound manner, with adequate capital and capable management.
